



## Campus Safety Conference 2022 Attendee Hotel Giveaway

### OFFICIAL RULES

#### **1. ELIGIBILITY; METHOD TO ENTER; SUBMISSION GUIDELINES.**

The Campaign is only open to legal residents of the continental U.S. and Canada, who are in the age of majority for their region at the time of participation, and is void where prohibited by law.
